MARNING

GUB0108 Windows should only be assembled with covers thick enough to ensure 8 full threads of engagement between the ring adapter and cover and between the window housing and ring adapter when installing GUB0108 window.




MARNING

To avoid the risk of fire, explosion, or electric shock: always disconnect primary power source before opening enclosure for inspection or service.

- Open enclosure cover (Item 1) and place on a smooth flat surface with the inside cover facing up.
- Apply Crouse-Hinds STL thread lubricant to the GUB0108 adapter ring (Item 2) and thread into cover from the inside making sure not to cross thread during installation, until fully seated agaisnt inside cover.
- 3. Place cover with adapter ring back onto the enclosure body and tighten all enclosure bolts to their recommended value.
- Apply Crouse-Hinds STL thread lubricant onto the threads of the GUB0108 window housing sub-assembly (Item 3) and screw into the adapter ring, ensuring window flange seats fully.
